Monthly Report on the Corporate Goods Price Index (Preliminary Figures for January 2021)

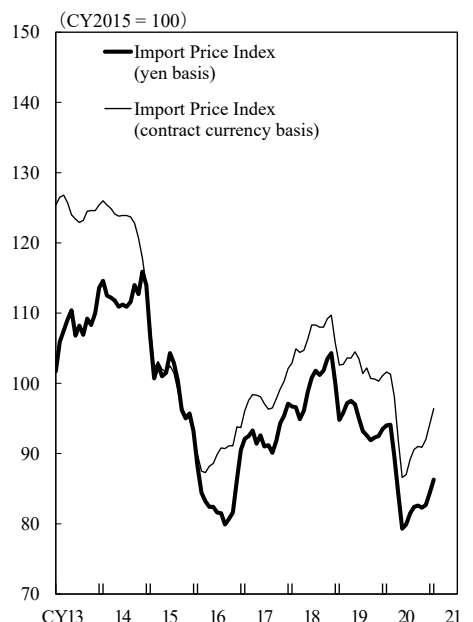
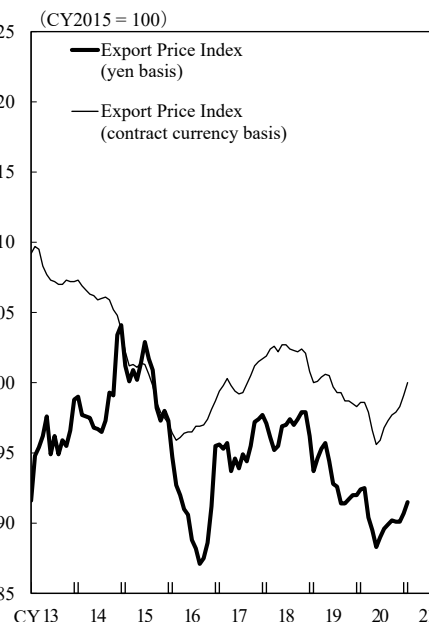
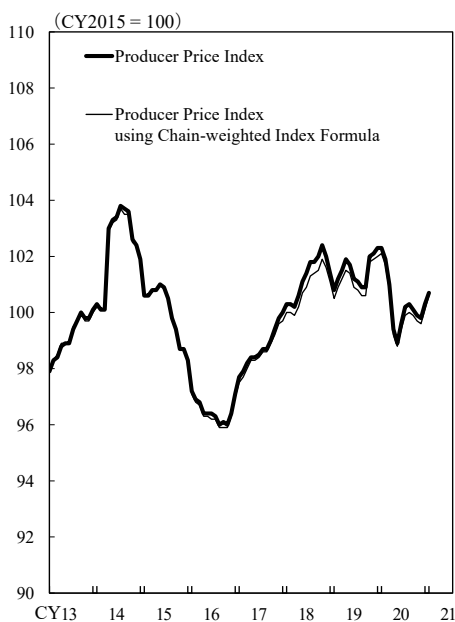
- ❖ The Producer Price Index rose 0.4 percent from the previous month.

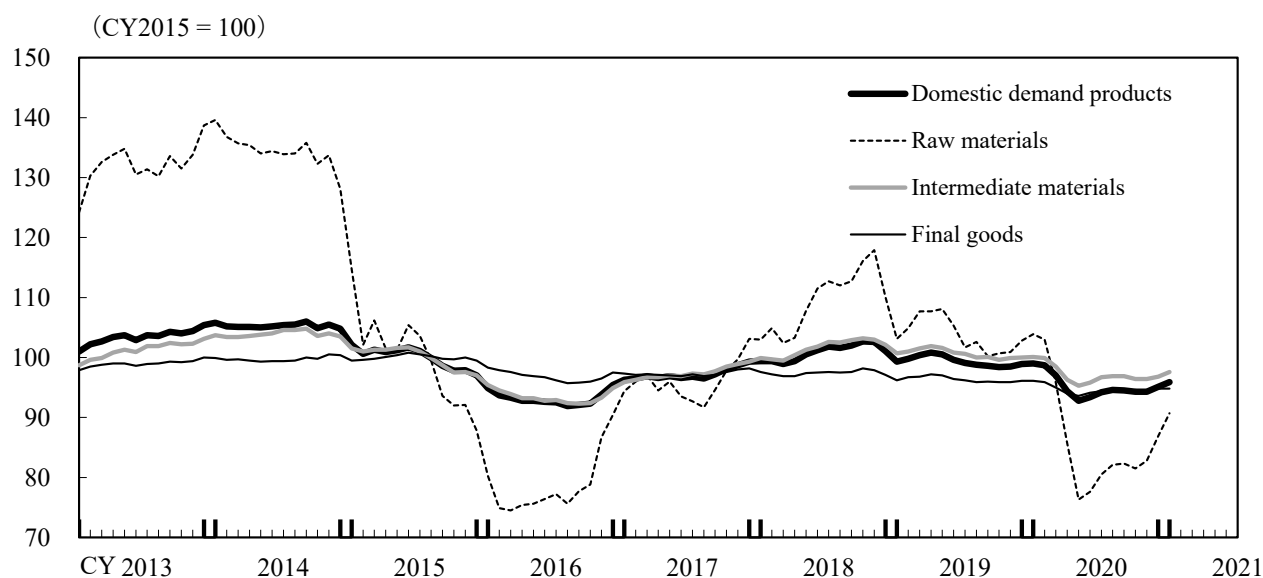
