- ❖ The Import Price Index (contract currency basis) fell 1.8 percent from the previous month.

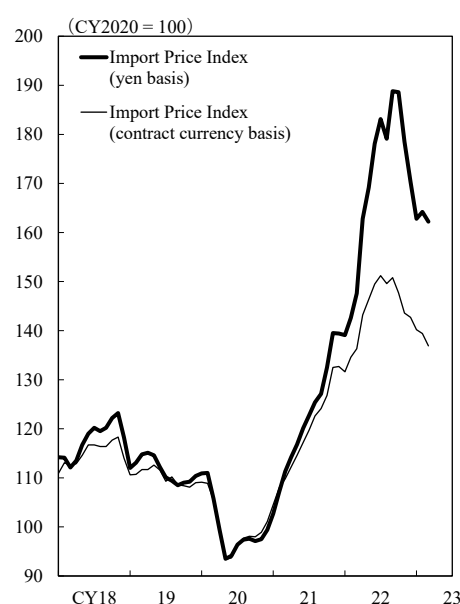
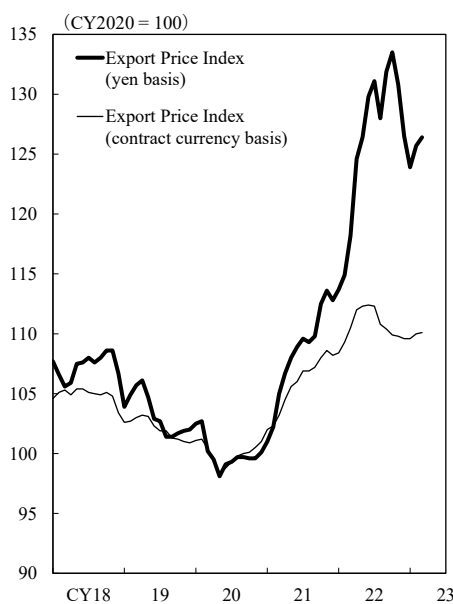
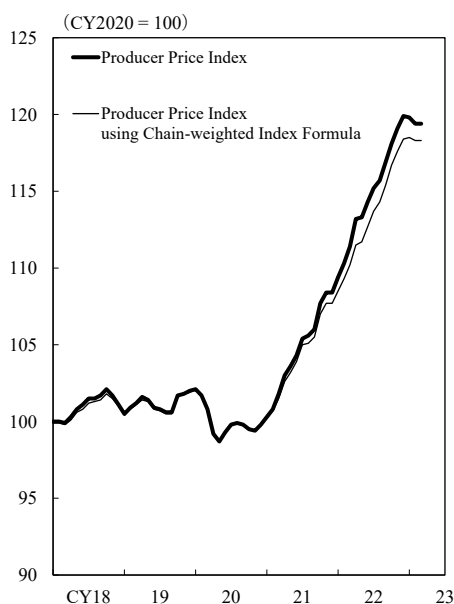
