Monthly Report on the Services Producer Price Index (Preliminary Figures for February 2024)

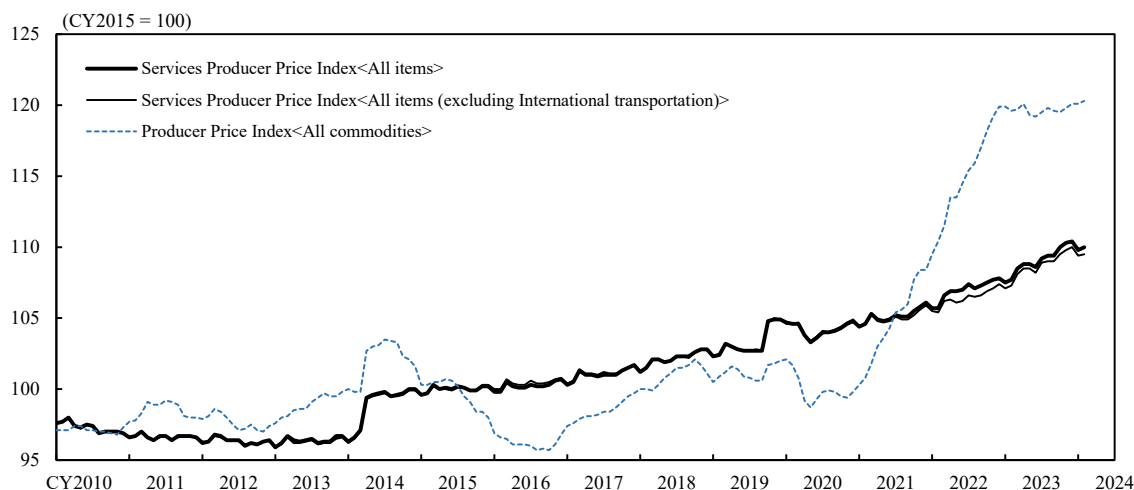
The Services Producer Price Index (All items) rose 2.1 percent from the previous year.
